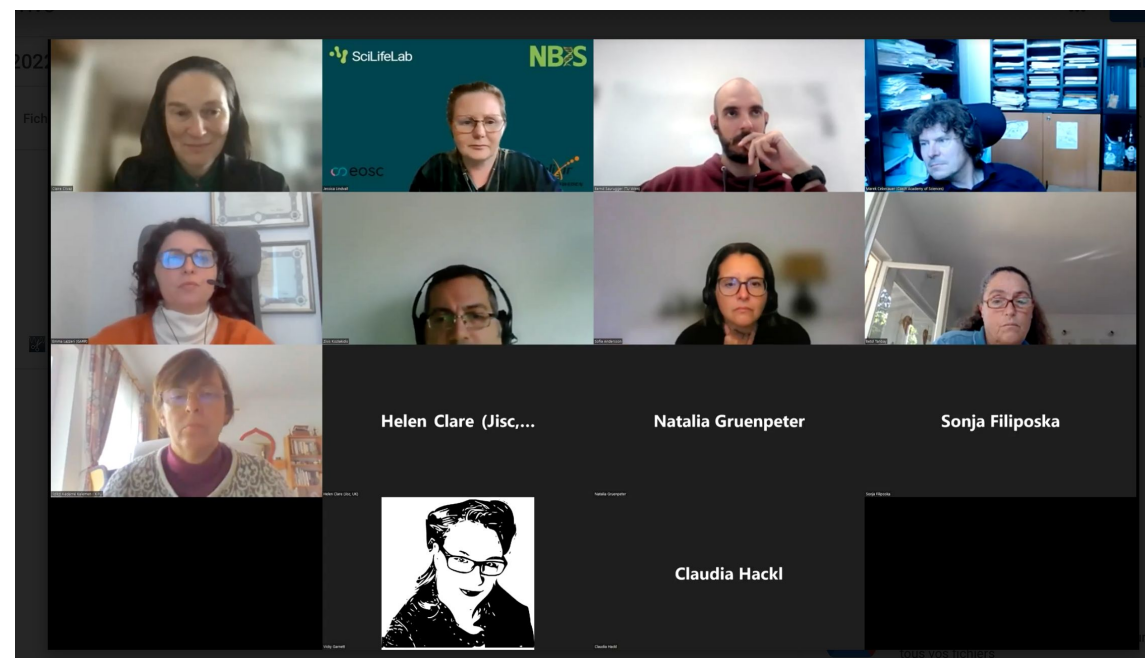

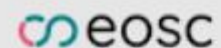

Our hopes

- To translate open science plans into concrete actions
- To show policy makers successful practices and case studies by their peers in Europe
- Show policy makers what has been achieved by 'bottom-up' initiatives
- Demonstrate value of EOOSC to encourage engagement from policy makers

Getting more from Tripartite events

- Involve researchers more with separate sessions, more practical ones, focused on tools, resources that are already available in EOSC.
- Ensure meaningful discussion of issues rather than just 'showcasing' success
- Ensure enough time (is one day enough?)
- Ensure the right stakeholders attend
- Good communication of events with enough notice





Beyond the events

- Be careful not to over-EOSC!
- Educate / prepare OS advocates to talk to the ministries
- Create "basic models" "templates" that suit all countries and that can be supplemented with what is country-specific
- Tips on overall collaboration/policy that can support the work throughout the ecosystem and make it connect
- Need follow up and continuation work
- Work with our TF!
